The Government of India has received financing from the World Bank toward the cost of the **Andhra Pradesh Municipal Development Project (APMDP)** and intends to apply part of the proceeds for consulting services.

"Preparation of DPRs of Water Supply, Septage Management and Storm water Drainage for non AMRUT ULBs in Andhra Pradesh (in different packages)".

The Commissioner & Director of Municipal Administration, Andhra Pradesh, Guntur now invites eligible Consulting firms ("Consultants") to indicate their interest in providing the above Services. Interested consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the required services (Branches, description of similar assignments, experience in similar conditions, availability of approximate skills among staff, financial etc).

The short listing criteria are: The firm should have at least 5 years standing in the field of consultancy. The firm should have a turnover of Rs. 4 Crore per year for the last three financial years. The firm should have completed at least three similar DPR preparation projects in previous 3 years in the above three sectors viz., water supply, septage / sewerage management and storm water drainage with clear documentary evidence of the lead firm.

The study will assess comprehensively the existing Water supply Management, Sewerage/septage Management and Storm water Drainage System in the ULB and develop service level improvement plans to improve the infrastructure, existing system performance, water supply source augmentation, septage treatment and management and storm water drainage covering capital improvement to enable the ULBs to deliver the desired services.

The attention of interested consultants is drawn to the paragraph 1.9 of the World Bank's Guidelines. Selection And Employment of consultants under IBRD Loans and IDA Credits & Grants by WORLD BANK borrowers January 2011 revised July 2014 ("Consultant Guidelines"). Setting forth the World Bank's policy on conflict of interest.

Consultants may associate with other firms in the form of a joint venture or a subconsultancy to enhance their qualifications. In case any firm wishes to associate with another firm, it should inform in their Expression of Interest about the nature of association whether as joint venture or as sub consultant.

A consultant will be selected in accordance with the Quality and Cost Based Selection (QCBS) method set out in the Consultant Guidelines.
