The Government of India has received financing from the World Bank towards the cost of the **Andhra Pradesh Municipal Development Project (APMDP)** and intends to apply part of the proceeds for consulting services.

“Revenue Database updation Survey and Rationalisation of House Numbering of 32 ULBs of Andhra Pradesh”. The towns shall be divided into 5 different packages under this same assignment . Each package is independent and there will be a separate short list for each packages.

The Project Director, Andhra Pradesh Municipal Development Project, Guntur now invites eligible Consulting firms (“Consultants”) to indicate their interest in providing the services. Interested consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the service (branches, description of similar assignments, experience in similar conditions, availability of approximate skills among staff, financial etc).

Short listing criteria are:

- i. The firm should have completed at least three similar projects in previous three years with clear documentary evidence of the lead firm, with total order value of at least Rs. 5 lakhs in last 3 financial years

- ii. The firm should have a turnover of Rs.4 crores per year in the last 3 financial years (2013-14, 2014-15 & 2015-16).

The attention of interested Consultants is drawn to the paragraph 1.9 of the World Bank's *Guidelines: Selection and Employment of Consultants Under IBRD Loans and IDA Credits & Grants by world bank borrowers* January 2011 Revised July 2014 ("Consultant Guidelines"), setting forth the World Bank's policy on conflict of interest.

Consultants may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications. In case any firm wishes to associate with another firm, it should inform in their Expression of Interest about the nature of association whether as joint venture or as sub-consultant.

A consultant will be selected in accordance with the Quality and Cost Based Selection (QCBS) method set out in the Consultant Guidelines.
