ORDER:

In the reference 1st read above, the Government have issued Operational Guidelines prescribing norms for improving service delivery levels in the maintenance of sanitation and solid waste management services in all the ULBs in a standardized and systematic manner including shifting from worker outsourcing method to work outsourcing method. The Guidelines further specifies procedures for planning the work packages for outsourcing etc.

2. Accordingly, ULBs have undertaken micro planning activities based on which, budget cost estimates were prepared to which ULB Municipal Councils accorded their approvals. Further, after obtaining Administrative approvals and Technical sanctions, ULBs have to take up Tendering process.

3. The Director Municipal Administration, AP, Guntur, vide letter 2nd read above, has requested the Government to approve certain procedures to be followed while undertaking the Tendering process by the ULBs and also requested to constitute Regional Bid Selection Committees for technical evaluation of the bids received.

4. In the reference 3rd read above, Government have approved the Procedures for Tender Process Management, Tenders Evaluation and Contracts Award for all the Residential and Residential cum Commercial Work Packages for Maintenance of Sanitation and Solid Waste Management implemented as per Operational Guidelines issued in G.O.Ms.No.279, MA&UD, dated.31-12-2015.

5. The Government, after careful examination of the proposal of the Director Municipal Administration, AP, Guntur, hereby constitute Regional Bid Selection Committees as detailed in the Table below:

6. The Regional Bid Selection Committees shall evaluate and finalize the Technical Evaluation part of the bids. The Technical Evaluation shall include all the parameters given in the Table below:

Parameters for Technical Evaluation	Maximum Marks
1. Work Experience of the Bidder	60 marks
2. Financial Turnover	10 marks
3. Networth	10 marks
4. Involvement in Corporate Social Responsibility Projects	10 marks
5. Approach and Methodology	10 marks
Total Marks for Technical Evaluation	100 marks

7. The evaluation parameters and methodology of evaluation and the procedures are specified in G.O. 3rd read above, and they have to be followed in to-to by the Regional Bid Selection Committees.

8. The Director of Municipal Administration, A.P., Guntur, shall take further necessary action in the matter, accordingly.

9. The Engineer-in-Chief, Public Health, Tadepalli, Chief Engineers of Grater Visakhapatnam Municipal Corporation, Visakhapatnam, and Municipal Corporation, Vijayawada, shall take into consideration the technical evaluation scores arrived at by the Regional Bid Selection Committees and accordingly give approval for Technical Evaluation process adopted by the ULBs.
