The attention of all the Commissioners of ULBs in the State is invited to the reference 2<sup>nd</sup> cited and it is informed that, Government in the G.O.Ms.No.296 Municipal Administration Department, dated:12.08.2015(Annexure-IV) have, issued guide lines for implementation of the Scheme of "Regularization of unobjectionable encroachments in Government lands by way of Dwelling units in Urban areas to an extent of up to 100 sq.yards to BPL families on free of cost" by following the guidelines issued by the Government.

- 2. In this regard, all the Commissioners of ULBs in the State were requested vide reference 2<sup>nd</sup> cited, to take immediate necessary action on the guide lines issued by the Government scrupulously wherein it was mentioned that the application shall be disposed off within in 90 days of its receipt, and furnish the information in the prescribed format enclosed(Annexure-II) by every fortnight to this office regularly with out fail. But no report has been received so far in the matter. As per the Mee Seva Online report(Annexure-III), it is observed that so far 13,317 applications have received in respect of 63 ULBs, out of 110 ULBs and the remaining 47 ULBs have not initiated any action to create awareness among the Public and to get applications obtained through Mee Seva.
- 3. Therefore while enclosing herewith a copy of the Pamphlet published (Annexure-I) by Municipal Commissioner, Chilakaluripet, all the Commissioners of ULBs in the State are once again requested to look into the matter personally and take necessary action as per the guidelines issued by the Government creating awareness among the public so as to enable them to file the applications for regularization Mee Seva and furnish the required information as called for in the prescribed format already Communicated on 25.8.2015 to this office, immediately, with out fail. Any failures in this regard will be viewed seriously.
