## Section I. Instructions to Bidders

### A. General

1.Scope of Bid	<p><b>1.1 The Purchaser indicated in the Bidding Data Sheet (BDS),</b> issues these Bidding Documents for the supply of Goods and Related Services incidental thereto as specified in Section VII, Schedule of Requirements. The name, identification and number of lots (contracts) of this National Competitive Bidding (NCB) procurement are <b>specified in the BDS.</b></p> <p><b>1.2</b> Throughout these Bidding Documents:</p> <ul style="list-style-type: none"> <li>a) the term “in writing” means communicated in written form (e.g. by mail, e-mail, fax, telex, including if <b>specified in the BDS</b>, distributed or received through the electronic-procurement system used by the Employer)with proof of receipt;</li> <li>b) if the context so requires, “singular” means “plural” and vice versa; and</li> <li>c) “day” means calendar day</li> </ul>
2. Source of Funds	2.1 AMRUT2.0 A&OE funds
3.Corrupt & Fraudulent Practices	<p>3.1 The Government requires compliance with its policy in regard to corrupt and fraudulent practices as set forth in Section VI.</p> <p>3.2 In further pursuance of this policy, Bidders shall permit and shall cause its agents (whether declared or not), sub-contractors, sub- consultants, service providers or suppliers and to permit the Purchaser to inspect all accounts, records and other documents relating to the submission of the application, bid submission (in case prequalified), and contract performance (in the case of award), and to have them audited by auditors appointed by the Purchaser.</p>
4. Eligible Bidders	<p>4.1 A Bidder may be an OEM or Subsidiary/ Authorized Distributor of the OEM in India who is registered under Indian Companies Act.</p> <p>4.2 A Bidder shall not have a conflict of interest. Any Bidder found to have a conflict of interest shall be disqualified. A Bidder may be considered to have a conflict of interest for the purpose of this bidding process, if the Bidder:</p> <ul style="list-style-type: none"> <li>a. directly or indirectly controls, is controlled by or is under common control with another Bidder; or</li> <li>b. receives or has received any direct or indirect subsidy from another Bidder; or</li> <li>c. has the same legal representative as another Bidder;</li> </ul>

	<p>or has a relationship with another Bidder, directly or through common third parties, that puts it in a position to influence the bid of another Bidder, or influence the decisions of the <b>Purchaser</b> regarding this bidding process; or</p> <ul style="list-style-type: none"> <li>e. Participates in more than one bid in this bidding process. Participation by a Bidder in more than one Bid will result in the disqualification of all Bids in which such Bidder is involved. However, this does not limit the inclusion of the same subcontractor in more than one bid; or</li> <li>f. any of its affiliates participated as a consultant in the preparation of the design or technical specifications of the goods/equipment that are the subject of the bid; or</li> <li>g. any of its affiliates has been hired (or is proposed to be hired) by the <b>Purchaser</b> for the Contract implementation; or</li> <li>h. would be providing goods, works, or non-consulting services resulting from or directly related to consulting services for the preparation or implementation of the project specified in the BDS ITB 2.1 that it provided or were provided by any of its affiliate that directly or indirectly controls, is controlled by, or is under common control with that firm; or</li> <li>i. has a close business or family relationship with a professional staff of the <b>Purchaser</b> (or of the project implementing agency) who: (i) are directly or indirectly involved in the preparation of the bidding documents or specifications of the contract, and/or the bid evaluation process of such contract; or (ii) would be involved in the implementation or supervision of such contract unless the conflict stemming from such relationship has been resolved in a manner acceptable to the Bank throughout the procurement process and execution of the contract.</li> </ul> <p>4.3 In case of Bidder, who is an OEM outside India, Guidelines and instructions issued by Ministry of Finance Department of Expenditure Public Procurement Division, New Delhi vide F.No.6/18/2019-PRD. Dated 23-07-2020), requiring DPIIT Registration shall be applicable.</p> <p>4.4 A Bidder may have the nationality of any country, subject to the restrictions pursuant to ITB 4.6. A Bidder shall be deemed to have the nationality of a country if the Bidder is constituted, incorporated or registered in and operates in conformity with the provisions of the laws of that country,</p>

	<p>as evidenced by its articles of incorporation (or equivalent documents of constitution or association) and its registration documents, as the case may be.</p> <p>4.5 A Bidder shall not be under suspension from bidding by the <b>Purchaser</b> as the result of the operation of a Bid–Securing Declaration.</p> <p>4.6 Bidders may be ineligible if so indicated in Section V and as a matter of law or official regulations, the Government of India prohibits commercial relations with that country.</p> <p>4.7 A bidder shall provide such evidence of eligibility to the satisfaction of the <b>Purchaser</b>, as the <b>Purchaser</b> shall reasonably request.</p>
<b>5. Eligible Goods and Related Services</b>	<p>5.1 All the Goods and Related Services to be supplied under the Contract may have their origin in any country, in accordance with Section V, Eligible Countries (As per Guidelines and instructions issued by Ministry of Finance Department of Expenditure Public Procurement Division, New Delhi vides F.No.6/18/2019-PRD. Dated 23-07-2020, Requiring DPIIT Registration.)</p> <p>5.2 For purposes of this Clause, the term “goods” includes Commodities, raw material, machinery, equipment, and industrial plants; and “related services” includes services such as insurance, installation, and initial maintenance.</p> <p>5.3 The term “origin” means the country where the goods have been mined, grown, cultivated, produced, manufactured or processed; or, through manufacture, processing, or assembly, another commercially recognized article results that differs substantially in its basic characteristics from its components.</p>

<b>6. Contract Forms</li> </ul> <p>6.2 The Invitation for Bids issued by the <b>Purchaser</b> is not part of the Bidding Document.</p> <p>6.3 Unless obtained directly from the <b>Purchaser</b>, the <b>Purchaser</b> is not responsible for the completeness of the document, responses to requests for clarification, minutes of pre-bid meeting (if any), or Addenda to the Bidding Document in accordance with ITB 8. In case of any contradiction, documents obtained directly from the <b>Purchaser</b> shall prevail.</p> <p>6.4 The Bidder is expected to examine all instructions, forms, terms, and specifications in the Bidding Documents and to furnish with its Bid all information or documentation as is required by the Bidding Documents.</p>
<b>7. Clarification of Bidding Documents</b>	<p>7.1 The electronic bidding system <b>specified in the BDS</b> provides for online clarifications. A prospective Bidder requiring any clarification on the Bidding Documents may notify the <b>Purchaser</b> online. Clarifications requested through any other mode shall not be considered by the <b>Purchaser</b>. The <b>Purchaser</b> will respond to any request for clarification, provided that such request is received not later than fifteen (15) days prior to the deadline for submission of bids. Description of clarification sought and the response of the <b>Purchasers</b> shall be uploaded for information of all Bidders without identifying the source of request for clarification. Should the <b>Purchaser</b> deem it necessary to amend the Bidding Documents as a result of a clarification, it shall do so following the procedure under ITB Clause 8 and ITB Sub-Clause 22.2. It is the bidder's responsibility to check on the e-procurement system, for any addendum/ amendment/ corrigendum to the bidding document.</p>
<b>8. Amendment of Bidding Documents</b>	<p>8.1 At any time prior to the deadline for submission of bids, the <b>Purchaser</b> may amend the Bidding Documents by issuing addendum. The addendum will appear on the e-procurement system under "Latest Corrigendum" and email notification is also automatically sent to those bidders who have started</p>

	<p>working on the tender or as <b>otherwise specified in BDS</b>.</p> <p>8.2 Any addendum thus issued shall be part of the Bidding Documents and shall be deemed to have been communicated to all the bidders.</p> <p>8.3 To give prospective Bidders reasonable time in which to take an addendum into account in preparing their bids, the <b>Purchaser</b> may, at its discretion, extend the deadline for the submission of bids, pursuant to ITB Sub- Clause22.2</p>
<b>C. Preparation of Bids</b>	
<b>9. Cost of Bidding</b>	<p>9.1 The Bidder shall be all costs associated with the preparation and submission of its bid, and the <b>Purchaser</b> shall not be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process</p>
<b>10. Language of Bid</b>	<p>10.1 The Bid, as well as all correspondence and documents relating to the bid exchanged by the Bidder and the <b>Purchaser</b>, shall be written in English language. Supporting documents and printed literature that are part of the Bid may be in another language provided they are accompanied by an accurate translation of the relevant passages into English language, in which case, for purposes of interpretation of the Bid, such translation shall govern.</p>
<b>11. Documents Comprising the Bid</b>	<p>11.1 The Bid shall comprise two Parts, namely the Technical Part and the Financial Part. These two Parts shall be submitted simultaneously.</p> <p>11.2 <b>The Technical Part</b> shall contain the following:</p> <ul style="list-style-type: none"> <li>(a) Letter of Bid – Technical Part, in accordance with ITB Clause 12;</li> <li>(b) Bid Security/ EMD, in accordance with ITB Clause 19.1, if required;</li> <li>(c) Alternative bids– Technical Part, if permissible, in accordance with ITB 13, the Technical Part of any Alternative Bid; written confirmation authorizing the signatory of the Bid to commit the Bidder, in accordance with ITB Clause 20.2; documentary evidence in accordance with ITB Clause 17 establishing the Bidder's qualifications to perform the contract if its bid is accepted;</li> <li>(e) documentary evidence in accordance with ITB 17 establishing the Bidder's eligibility to bid;</li> </ul>

	<p>(f) documentary evidence in accordance with ITB Clause 16, that the Goods and Related Services to be supplied by the Bidder are of eligible origin;</p> <p>(g) Joint Venture is not applicable</p> <p>(h) Manufacturer's authorization form; and</p> <p>(i) any other document <b>required in the BDS.</b></p> <p>11.3 The <b>Financial Part</b> shall contain the following:</p> <p>(a) Letter of Bid – Financial Part: prepared in accordance with ITB 12 and ITB14;</p> <p>(b) Price Schedules: completed prepared in accordance with ITB 12 and ITB14;</p> <p>(c) Alternative Bid - Financial Part; if permissible in accordance with ITB 13, the Financial Part of any Alternative Bid; and</p> <p>(d) Any other document <b>required in the BDS.</b></p> <p>11.4 The Technical Part shall not include any financial information related to the Bid price. Where material financial information related to the Bid price is contained in the Technical Part, the Bid shall be declared non-responsive.</p> <p>11.5 The Bidder shall furnish in the Letter of Bid, information on commissions and gratuities, if any, paid or to be paid to agents or any other party relating to this Bid.</p>
<p><b>12. Process of Bid Submission</b></p>	<p>12.1 The Letter of Bid – Technical Part, Letter of Bid – Financial Part and Price Schedules shall be prepared using the relevant forms furnished in Section IV, Bidding Forms. The forms must be completed without any alterations to the text, and no substitutes shall be accepted except as provided under ITB 20.2. All blank spaces shall be filled in with the information requested.</p> <p>12.2 Entire Bid including the Letter of Bid and filled-up Price Schedules shall be submitted online on e-procurement system specified in ITB 7.1. Details and process of online submission of the tender and relevant documents are given in the website mentioned above. Scanned copies of documents listed in clauses 11 and 12.3 should also be uploaded on this website.</p> <p>12.3 <b>Submission of Original Documents:</b> The bidders are required to separately submit (i) original demand</p>



	<p>drafts towards the cost of bid document and registration on e- procurement website (if not previously registered) (as per RFB); (ii) original bid security in approved form; and (iii) original affidavit regarding correctness of information furnished with bid document, with the office <b>specified in the BDS</b>, before the opening of the technical part of the Bid, either by registered/speed post/courier or by hand, failing which the bids will be declared non-responsive and will not be opened. Hard copy of rest of the bid is not to be submitted.</p>
<b>13. Alternative Bids</b>	<p>13.1 Unless otherwise <b>specified in the BDS</b>, alternative bids shall not be considered.</p>
<b>14. Bid Prices and Discounts</b>	<p>14.1 The prices and discounts quoted by the Bidder in the Letter of Bid – Financial Part and in the Price Schedules shall conform to the requirements specified below.</p> <p>14.2 All lots (contracts) and items must be listed and priced separately in the Price Schedules.</p> <p>14.3 The price to be quoted in the Letter of Bid – Financial Part, in accordance with ITB 12.1, shall be the total price of the bid, excluding any discounts offered.</p> <p>14.4 The Bidder shall quote any discounts and indicate the methodology for their application in the Letter of Bid – Financial Part in accordance with ITB 12.1.</p> <p>14.5 Prices quoted by the Bidder shall be fixed during the Bidder's performance of the Contract and not subject to variation on any account, <b>unless otherwise specified in the BDS</b>. A bid submitted with an adjustable price quotation shall be treated as non-responsive and shall be rejected, pursuant to ITB 31. However, if in accordance with the BDS, prices quoted by the Bidder shall be subject to adjustment during the performance of the Contract, a bid submitted with a fixed price quotation shall not be rejected, but the price adjustment shall be treated as zero.</p> <p>14.6 If so specified in ITB 1.1, bids are being invited for individual lots (contracts) or for any combination of lots (packages).
